

**“2024 LEXUS ULTIMATE DAY OF GOLF” SWEEPSTAKES
OFFICIAL RULES**

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID OUTSIDE THE STATE OF NEW YORK, NEW JERSEY AND CONNECTICUT AND WHERE PROHIBITED OR RESTRICTED BY LAW.

DATES OF SWEEPSTAKES: The “2024 Lexus Ultimate Day of Golf” Sweepstakes (the “Sweepstakes”) begins at 12:00 a.m. Eastern Standard Time (“EST”) on May 16, 2024 and ends at 11:59 p.m. EST on June 6, 2024 (the “Sweepstakes Period”).

ELIGIBILITY: The Sweepstakes is open only to legal residents of the states of New York, New Jersey or Connecticut who are at least twenty one (21) years of age at time of entry (each, an “Entrant”). Officers, directors, managers and employees of Team One, a division of Saatchi & Saatchi North American, LLC (“Agency”), the Eastern Area Lexus Dealer Advertising Association, Inc. (the “Sponsor”), Toyota Motor Sales USA, Inc., Metropolitan Golf Association (“MGA”) and each of their respective parent companies, subsidiaries, affiliates, and related companies, dealers, advertising and promotion agencies, consultants and agents, and any others engaged in the development, production, execution or distribution of this Sweepstakes (collectively, the “Sweepstakes Entities”), including National Sweepstakes Company, LLC (the “Independent Administrator”) as well as immediate family (spouse, parents, siblings and children and their respective spouses, regardless of where they reside) and household members of each such person, whether or not related, are not eligible to participate. Sweepstakes is subject to all applicable federal, state and local laws and regulations. Sweepstakes is void outside the states of New York, New Jersey and Connecticut and wherever else restricted or prohibited by law. Persons who have previously won a contest, sweepstakes or promotion of any kind sponsored or otherwise associated with Agency, Eastern Area Lexus Dealer Advertising Association, Inc. or Toyota Motor Sales, U.S.A., Inc. within thirty (30) calendar days immediately preceding the start of this Sweepstakes are ineligible to participate or win the Grand Prize.

NOTE: The Entrant selected as the potential grand prize winner (the “Grand Prize Winner”) will be notified by telephone starting on or about June 8, 2024 through July 12, 2024. Entrants must provide a telephone number through which they can be reached on such dates. See the “WINNER SELECTION/NOTIFICATION” and “PRIZE” section of these Official Rules for complete details.

HOW TO ENTER: To enter, visit www.mgagolf.org/lexus/ultimatedayofgolf (the “Website”) during the Sweepstakes Period, click on the Sweepstakes image and complete the official entry form (the “Entry Form”) in its entirety including your first name, last name, address, city, state, zip code, email address (not required), telephone number where you can be reached for potential Grand Prize winning notifications (including area code), if selected, and date of birth. Then, click the “Submit” button in order to receive one (1) entry into the Sweepstakes. **There is a limit of one (1) entry per Entrant during the Sweepstakes Period.**

Neither Sponsor or any Sweepstakes Entity is responsible for any entry that is lost, late, garbled, stolen, delayed, misdirected or undeliverable, whether due to system errors, omissions, interruption, deletions, defects, delay in operations or transmissions, theft or destruction or failures, faulty transmissions or other telecommunications malfunctions, entries not received resulting from any hardware or software failures of any kind, lost or unavailable network connections, failed, incomplete or garbles computer or telephone transmissions, typographical or system errors and failures, faulty transmissions, technical malfunctions, or otherwise.

Any attempt by an Entrant to obtain more than the stated number of entries by using multiple/different identities, and/or any other methods will void that Entrant’s entry and that Entrant may be disqualified from the Sweepstakes. In the event of a dispute regarding the identity of the person submitting an entry, the entry will be deemed submitted by the person in whose name and mailing address were submitted via the Entry Form (the “Authorized Account Holder”) and such Authorized Account Holder must comply with these Official Rules. The potential Grand Prize Winner may be required to show proof of being the Authorized Account Holder. If the Sponsor cannot determine the identity of the person based upon the information submitted via the Entry Form, the respective Entrant will be disqualified.

No mechanically or programmatically reproduced entries are permitted. Sponsor will not verify receipt of entries for Entrants. All entries submitted become the sole property of Sponsor and will not be returned. By entering, each Entrant; (a) represents that they are at least twenty-one (21) years of age and otherwise eligible to participate in the Sweepstakes; and (b) fully and unconditionally agrees to and accept these Official Rules and the decisions of Sponsor, which are final and legally binding in all respects. Any person who tampers with the entry process in any way will be disqualified.

WINNER SELECTION/NOTIFICATION: On or about June 7, 2024, one (1) potential Grand Prize Winner will be selected at random from among all eligible entries received during the Sweepstakes Period. Odds of being selected as the Grand Prize

Winner are based upon the total number of eligible entries received during the Sweepstakes Period. **The potential Grand Prize Winner will be notified by telephone between the hours of 8:30 a.m. EST and 4:30 p.m. EST from June 10, 2024 to July 12, 2024 (“Notification”).** Independent Administrator will make two (2) attempts to reach the potential Grand Prize Winner via the Notification. **Notifications will not be left on answering machines / voicemail.** If the potential Grand Prize Winner cannot be reached after two (2) attempts have been made, or, if he/she is ineligible in accordance with these Official Rules, as determined by the Sponsor/Independent Administrator in their sole discretion, he/she will be disqualified without compensation of any kind, and an alternate will be selected at random from among the remaining non-winning eligible entries received, and notified as outlined above, time permitting. The awarding of the Grand Prize will commence immediately upon receipt of the “Required Documents” (further defined in the “PRIZE CLAIMS” section below). The random drawing and determination of the Grand Prize Winner will be conducted by the Independent Administrator whose decisions are based upon their sole discretion of these Official Rules and are final and binding in all respects.

PRIZE: One (1) Grand Prize Winner will be awarded i) one (1) 18 hole round of golf at a premiere New York, New Jersey or Connecticut Golf Course for Grand Prize Winner and three (3) guests, ii) Lunch at the Golf Course for Grand Prize Winner and three (3) guests, iii) one (1) dozen Callaway ChromeSoft golf balls and iv) \$100 Golf Shop Credit per player. Approximate Retail Value (“ARV”) of Grand Prize: \$1,500. All Grand Prize details are at the sole discretion of the Sponsor. Grand Prize Winner cannot assign or transfer Grand Prize to another person. No Grand Prize substitution or cash alternative is allowed except at the sole discretion of Sponsor, who reserves the right to substitute any portion of the Grand Prize with a prize of comparable or greater value, in their sole discretion.

Names of prize manufacturers are used solely for the purpose of identification of the prize. No endorsement, authorization, sponsorship, or approval by prize manufacturer for this Sweepstakes is intended or implied.

GOLF EXPERIENCE MUST BE TAKEN ON THE DATES INDICATED BY SPONSOR OR GRAND PRIZE WILL BE FORFEITED WITHOUT COMPENSATION OF ANY KIND. Golf Experience will need to occur between August 1, 2024-September 30, 2024. In such case an alternate Grand Prize Winner will be selected, time permitting. Sponsor reserves the right to change or adjust the aforementioned travel dates, at its sole discretion. All guests must be twenty-one (21) years of age or older. The Golf Course will be determined by the Sponsor depending on the location of the Grand Prize Winner and the Golf Courses available in the Grand Prize Winner’s area. Golf Experience may be subject to change due to impracticability or unavailability, or for any other reason as determined necessary by Sponsor or its designee, and are subject to any and all applicable health and safety protocols (which may be dictated by provider/location policies and/or state and/or local government requirements – all of which are subject to change at any time, including as the result of the COVID-19 pandemic). Grand Prize Winner and guests must adhere to the requirements of the golf course for any vaccinations/testing in order to participate. Any depictions of the Grand Prize are for illustrative purposes only and may not reflect the actual Grand Prize awarded. Any difference in the ARV listed herein and the actual value of the Grand Prize at the time for which it is awarded will not be awarded to the Grand Prize Winner. Grand Prize Winner agrees to undertake and participate in any Grand Prize related activities at his/her own risk. All arrangements must be made through the Sponsor. Once dates have been booked, no changes, extensions or substitutions are permitted, except at Sponsor’s sole discretion. Sponsor will not replace any lost, mutilated or stolen tickets, gift cards, or travel vouchers (if applicable). Grand Prize Winner is solely responsible for all costs, expenses, and incidentals associated with Grand Prize acceptance and use, including, but not limited to, additional ground transportation, parking, meals, beverages, gratuities, phone calls, insurance, taxes, and any other expenses not specifically mentioned as being included. If the potential Grand Prize Winner fails to return the Required Documents within twenty-four (24) hours of receiving it, the potential Grand Prize Winner forfeits his/her right to the Grand Prize and another potential Grand Prize Winner will be selected at random from among the remaining non-winning eligible entries received during the Sweepstakes Period, time permitting. At the end of the tax year for which the Grand Prize is awarded, Grand Prize Winner will be issued a Form 1099 equivalent to the retail value of the Grand Prize, for income verification and tax purposes. Grand Prize Winner is advised to seek independent counsel regarding the tax implications of his/her Grand Prize winnings. **Potential Grand Prize Winner must report income to the IRS. PUBLICITY GRANT: Grand Prize Winner consents (and agrees to sign any additional documents required by Sponsor, Agency, Toyota Motor Sales USA, Inc., or MGA to formalize, effect or perfect such consent, except where prohibited by law) to Sponsor, Agency, Toyota Motor Sales USA, Inc., or MGA's use of his/her name, likeness (photograph and/or video), biographical information, and voices in advertising/publicity/trade without limitation and without compensation, notice or approval; and, Grand Prize Winner disclaims any ownership rights of such advertising/publicity/trade material.

Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner and void all associated entries. Sponsor reserves the right to disqualify or reject any incomplete, inaccurate or false entry. **ANY ATTEMPT BY ANY PERSON TO DELIBERATELY UNDERMINE THE LEGITIMATE OPERATION OF THE SWEEPSTAKES IS A VIOLATION OF CRIMINAL AND CIVIL LAW, AND, SHOULD SUCH AN ATTEMPT BE MADE, SPONSORS RESERVE THE RIGHT TO SEEK DAMAGES FROM ANY SUCH PERSON TO THE FULLEST EXTENT PERMITTED BY LAW. In no event shall entrant seek or be entitled to rescission, injunctive, or other equitable relief or to enjoin or restrain the operation of this Sweepstakes, exploitation of any advertising or other materials issued in connection therewith, or exploitation of this Sweepstakes or any content or other material used or displayed on this Sweepstakes. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the entrant and Sponsor in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the laws of the State of New York, without giving effect to any choice of law or conflict of law rules (whether of the State of New York or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of New York.
