## "2024 LEXUS ULTIMATE DAY OF GOLF" SWEEPSTAKES OFFICIAL RULES

Then, click the "Submit" button in order to receive one (1) entry into the Sweepstakes. **There is a limit of one (1) entry per Entrant during the Sweepstakes Period.**
