Bring this certificate to your local participating Lexus dealer by 10/31/2024. This certificate will entitle you to \$1,000 from Lexus toward the purchase or lease of a new Lexus. Customer Instructions: Valid for the person named above who purchases or leases a new Lexus vehicle at a participating Lexus dealer in Connecticut, Delaware, Maine, Maryland, Massachusetts, New Hampshire, New Jersey, New York, Pennsylvania, Rhode Island, District of Columbia, Vermont, Virginia and West Virginia. Offer void where prohibited. Negotiate your best deal first, then give the \$1,000 certificate to your dealer who will apply the discount toward the payment on a finance contract or as a capitalized cost reduction on a lease. For a lease payable only in one payment, certificate will be applied toward the total payment due at lease signing. If your vehicle is purchased for cash or financed through a lender other than the dealer, the certificate will be applied to the cash sales price. This certificate is transferable within a customer's immediate family (spouse or children) residing at the same address. Limit one certificate per any new Lexus. Eligibility: Toyota Motor Sales, U.S.A., and its respective parent companies, divisions, affiliations, subsidiaries, advertising and promotion agencies, and each of their respective officers, directors, representatives, agents and employees and the immediate family members and/or those living in the same household of such officers, directors, representatives, agents and employees are not eligible to redeem this certificate. The original recipient of the certificate must be a Metropolitan Golf Association member as of July 9, 2024. The incentive will not be applied until membership can be verified. Dealer Instructions: Apply this certificate toward the down payment or capitalized cost reduction.
